

## **INDIVIDUAL REGISTRATION TERMS & CONDITIONS**

Your registration for the congress includes:

## **REGISTRATION FEES, PAYMENT, AND INVOICING**

- All fees are quoted in USD and do not include any applicable local or administrative taxes.
- For payments made in Argentina, a 21% I.V.A. tax will be added to all registration fees, payable in Argentine pesos according to the Banco Nación Venta exchange rate on the date of payment.
- Billing information can be entered during the online registration process. Once payment is completed, billing details cannot be changed. Please ensure that your billing address and information are accurate during registration.
- The prices listed apply only if both the registration request and payment are received before midnight (GMT-3) on the corresponding deadline; otherwise, the higher registration fee will be applied.

## **REGISTRATION PAYMENT**

- You can securely make credit card payments online (Visa, MasterCard, or American Express).
- Bank transfers don't have any extra fees for the person making the payment.
- Payments via bank transfer are accepted until **September 1st, 2025**. After that date, payments should be released by credit card or directly at the congress registration desk.
