

### Registration and Abstract Submission Process

The registration and abstract submission will be done using the following link:

Both, registration and abstract submission are limited by the event venue.

Abstracts must contain data from basic, translational, clinical and/or epidemiological research related to the developmental origins of health and disease or how the environment shapes the development of an organism. All the selected abstracts must be presented in-person.

#### Deadline for abstract submission

**Abstract submission deadline: July 31, 2025, 11:59 p.m. (local time in Brazil).**

#### Participation

1. Oral presentation
2. Poster presentation

During the abstract submission, you will be asked to select your preference for participation (oral or poster). However, the evaluators will have the option of proposing the mode of presentation according to the quality and novelty of the results presented.

All presentation will be done in English.

#### Abstract review process

The abstracts submitted will go through a peer review process, aiming to ensure quality and select the best abstracts for oral presentation. After this evaluation, the authors will be notified by email.

#### Guidelines to submit abstracts:

1. An individual may be the first (presenting) author on only one abstract. However, an author's name may appear on multiple abstracts as a co-author. Each co-author must agree, in principle, with the information and conclusions contained within the abstract.
2. The presenting author must have a unique and valid e-mail address at which he/she may be contacted.
3. The presenting author must certify that the conditions for submission have been satisfied and that all animal and human welfare and ethical considerations have been met. This information must be included in the abstract. Abstracts that do not include this information will not be accepted for presentation in this meeting.
4. Submission of an abstract constitutes an in-principal agreement that the presenting author will register and attend the meeting to present the abstract as an Oral Presentation or a Poster. The presenting author must register for the meeting when submitting the abstract.
5. Individuals wishing their abstract to be considered for oral presentation must indicate their eligibility at the time of the abstract submission. The Scientific Committee will select studies for oral presentation based on an evaluation of the presented abstracts.
6. Each author must disclose any financial, personal, or professional relationships with other people or organizations that could reasonably be perceived as conflicts of interest or as potentially influencing or biasing their work. Author(s) disclosure(s) must appear on the oral abstract presentation slides or poster presentation board.
7. Abstracts should be no longer than 2,500 characters **including title, author(s), affiliations and spaces** and prepared as a single paragraph, single-spaced.
8. The whole abstract should be written in Arial 12, using a justified text. The format for the different sections of the abstract is as follows:

**Title:** bold, and maximum 20 words.

**Authors:** full name of the authors without titles (family name and first name).

**Affiliations:** name of the institution(s) where the work was carried out. Use superscript numbers for each institution in cursive

**Presenting author e-mail:** include the presenting author's email for correspondence.

9. The body of the abstract must contain the following sections: Background/aims, Methods, Results, Conclusions, Funding, Key-words: (up to 5).

10. For submitting your abstract, please upload it in the registration formulary specific session following the instructions. You must attach (a) a file with the abstract (named with the last name of the first author), and (b) proof of payment of the registration fee.

11. The registration must be confirmed by the payment of registration fee, as indicated in the table. Data for the payment:
